Hacken OÜ (Consultant) was contracted by Sekuritance (Customer) to conduct a Smart Contract Code Review and Security Analysis. This report presents the findings of the security assessment of Customer's smart contract and its code review conducted on May 4<sup>th</sup>, 2021.

## Scope

We have scanned these smart contracts for commonly known and more specific vulnerabilities. Here are some of the commonly known vulnerabilities that are considered:

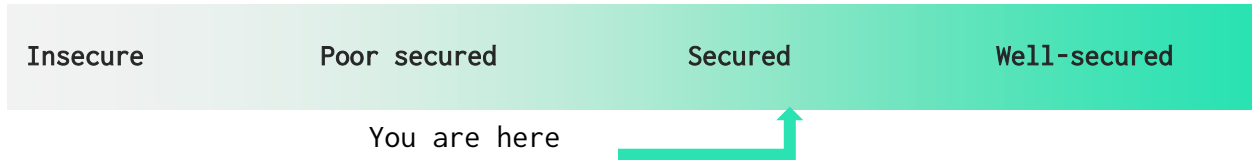

## Executive Summary

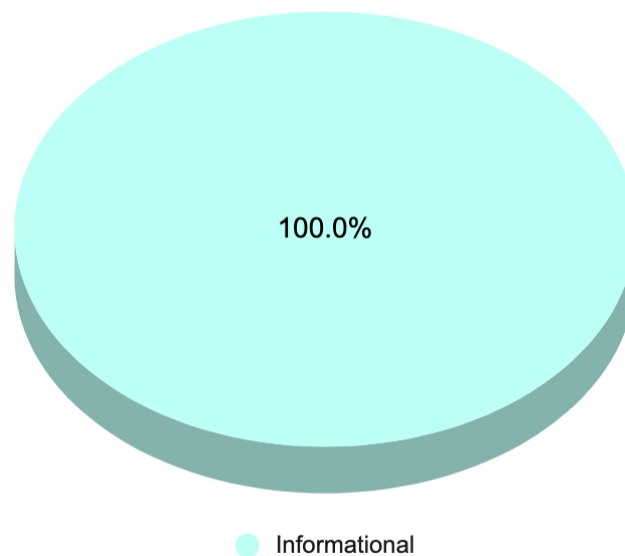
According to the assessment, the Customer's smart contract is secured



Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

Security engineers found 4 informational issues during the first review.

## Severity Definitions

Risk Level	Description
<b>Critical</b>	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
<b>High</b>	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
<b>Medium</b>	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
<b>Low</b>	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution
<b>Lowest / Code Style / Best Practice</b>	Lowest-level vulnerabilities, code style violations, and info statements can't affect smart contract execution and can be ignored.

#### 1. Vulnerability: Incorrect versions of Solidity

Solidity version 0.5.12 is not recommended for deployment. Please consider using any of the following Solidity versions:

- 0.5.16 - 0.5.17
- 0.6.11 - 0.6.12
- 0.7.5 - 0.7.6

Use a simple pragma version that allows any of these versions. Consider using the latest version of Solidity for testing.

#### 2. Vulnerability: State variable that should be immutable

State variables that got initialized in the constructor and don't change their value should be declared immutable to save gas.

#### 3. Vulnerability: Public function that could be declared external

**public** functions that are never called by the contract should be declared **external** to save gas.
