Introduction

Hacken OÜ (Consultant) was contracted by Firebird (Customer) to conduct a Smart Contract Code Review and Security Analysis. This report presents the findings of the security assessment of Customer's smart contract and its code review conducted between June 11th, 2021 – June 14th, 2021. The second code review conducted on June 16th, 2021.

Scope

We have scanned these smart contracts for commonly known and more specific vulnerabilities. Here are some of the commonly known vulnerabilities that are considered:



According to the assessment, the Customer's smart contract is secured but could be optimized in gas usage.




Security engineers found 1 low and 2 informational issues during the first review.

Severity Definitions

Risk Level	Description
Critical	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
High	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
Medium	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
Low	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution
Lowest / Code Style / Best Practice	Lowest-level vulnerabilities, code style violations, and info statements can't affect smart contract execution and can be ignored.

■ Lowest / Code style / Best Practice

1. **Vulnerability:** Public function that could be declared external

public functions that are never called by the contract should be declared **external** to save gas.
