## Executive Summary

According to the assessment, the Customer's smart contracts are well-secured.



Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found **2** low severity issues.

After the second review security engineers found **1** low issue was fixed.

## Severity Definitions

Risk Level	Description
<b>Critical</b>	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
<b>High</b>	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
<b>Medium</b>	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
<b>Low</b>	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution

## Audit overview

### ■ ■ ■ ■ Critical

No critical issues were found.

### ■ ■ ■ High

No high severity issues were found.

### ■ ■ Medium

No medium severity issues were found.

### ■ Low

1. A public function that could be declared external

**public** functions that are never called by the contract should be declared **external** to save gas.

**Contracts:** ChimUpgradeableV1.sol

**Function:** initialize

**Recommendation:** Use the **external** attribute for functions never called from the contract.

**Status:** Fixed.

2. Block timestamp

Dangerous usage of block.timestamp. block.timestamp can be manipulated by miners. Some contracts are fully related on the block.timestamp.

The maximum time which could be manipulated by a malicious miner is up to 15 minutes.

**Contracts:** ChimVesting.sol

**Recommendation:** Please consider relying on the block.number instead.

**Status:** Customer acknowledged.



## Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found **2** low severity issues.

After the second review security engineers found **1** low issue was fixed.
