This report presents the findings of the security assessment of the Customer's smart contract and its code review conducted between October 1<sup>st</sup>, 2021 - October 14<sup>th</sup>, 2021.

## Executive Summary

According to the assessment, the Customer's smart contracts are well-secured.



Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found 2 medium and 1 low severity issues.

After the second review security engineers found no security issues.

## Severity Definitions

Risk Level	Description
<b>Critical</b>	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
<b>High</b>	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
<b>Medium</b>	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
<b>Low</b>	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution

## Audit overview

### Critical

No Critical severity issues were found

### High

No high severity issues were found.

### Medium

#### 1. External call in the loop

Making an external call in the loop cause excess gas usage. It's more efficient to store the value to the local variable and access it in the loop instead.

**Contracts:** PortController.sol

**Functions:** issue, redeem

**Recommendation:** please consider saving the value to the local variable.

**Status:** Fixed.

#### 2. Possible inaccessible contract

View function which iterates through the array of undefined size could be out-of-work in the case when there would be a huge amount of values inside the array.

**Contracts:** PortFactory.sol

**Functions:** userPortTokens

**Recommendation:** please consider changing the logic for calculating values without using for-loops.

**Status:** Fixed by removing the function.

### Low

#### 1. A public function that could be declared external.

**public** functions that are never called by the contract should be declared **external** to save gas.

**Contracts:** PortController.sol, PortFactory.sol, WrappedToken.sol

**Functions:** issue, redeem, issueFromOtherToken, issueFromWrappedToken, redeemToOtherToken, redeemToWrappedToken, createPortToken, userPortTokens, deposit, withdraw

**Recommendation:** Use the **external** attribute for functions never called from the contract.

**Status:** Fixed.



## Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found **2** medium and **2** low severity issues.

After the second review security engineers found no security issues.
