Executive Summary

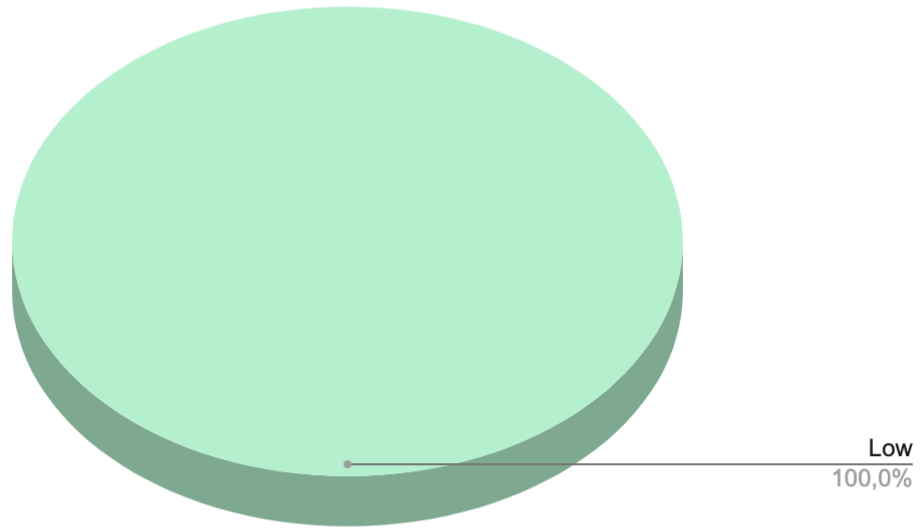
According to the assessment, the Customer's smart contracts are well-secured.



Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found **5** low severity issues.

Severity Definitions

Risk Level	Description
Critical	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
High	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
Medium	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
Low	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution

1. A public function that could be declared external.

public functions that are never called by the contract should be declared **external** to save gas.

Functions: name, symbol, decimals, totalSupply, transfer, allowance, approve, transferFrom, increaseAllowance, decreaseAllowance, isExcludedFromReward, totalFees, deliver, reflectionFromToken, excludeFromReward, excludeFromFee, includeInFee, setSwapAndLiquifyEnabled, setBlackHole, isExcludedFromFee

Recommendation: Use the **external** attribute for functions never called from the contract.

2. Dead code

Contracts: SpaceDogeCoin.sol

Functions: _tokenTransfer

Line #1172 is unreachable since previous if/else if statements cover all possible cases.

Recommendation: Remove lines #1171, #1172 and remove if statement from line #1169

3. Misleading error message

Error message does not describe the error correctly

Contracts: SpaceDogeCoin.sol

Functions: includeInReward (line #870)

Recommendation: Change error message



4. Unused private functions

Contracts: SpaceDogeCoin.sol

Functions: addLiquidity, swapTokensForEth

Recommendation: Remove unused private functions

5. State variables that could be declared constant

Constant state variables should be declared constant to save gas.

Contracts: SpaceDogeCoin.sol

Variables: _decimals, _name, _symbol, _tTotal

Recommendation: Add the constant attributes to state variables that never change.



Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found **5** low severity issues.
