## Executive Summary

According to the assessment, the Customer's smart contracts are well-secured.



Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found 1 high and 1 low severity issue.

As a result of the second review, security engineers found **no** issue.

## Severity Definitions

Risk Level	Description
<b>Critical</b>	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
<b>High</b>	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
<b>Medium</b>	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
<b>Low</b>	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution

No critical issues were found.

### ■ ■ ■ High

All token transfers can be stopped by owners. Such functionality can be used to manipulate the market

**Contracts:** Trickle.sol

**Functions:** pause

**Recommendation:** The owner must be a contract with transparent rules for using the pause function. Else remove this function.

**Status:** fixed.

### ■ ■ Medium

No medium severity issues were found.

### ■ Low

“hardhat/console.sol” is imported but never used

**Contracts:**Trickle.sol

**Recommendation:** remove unused import.

**Status:** fixed.



## Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found **1** high and **1** low severity issue.

As a result of the second review, security engineers found **no** issue.
