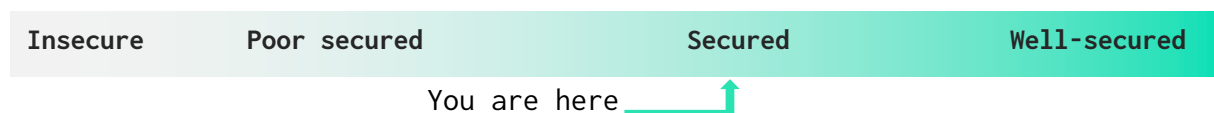
We have scanned this smart contract for commonly known and more specific vulnerabilities. Here are some of the commonly known vulnerabilities that are considered:

According to the assessment, the Customer's smart contracts are secured.

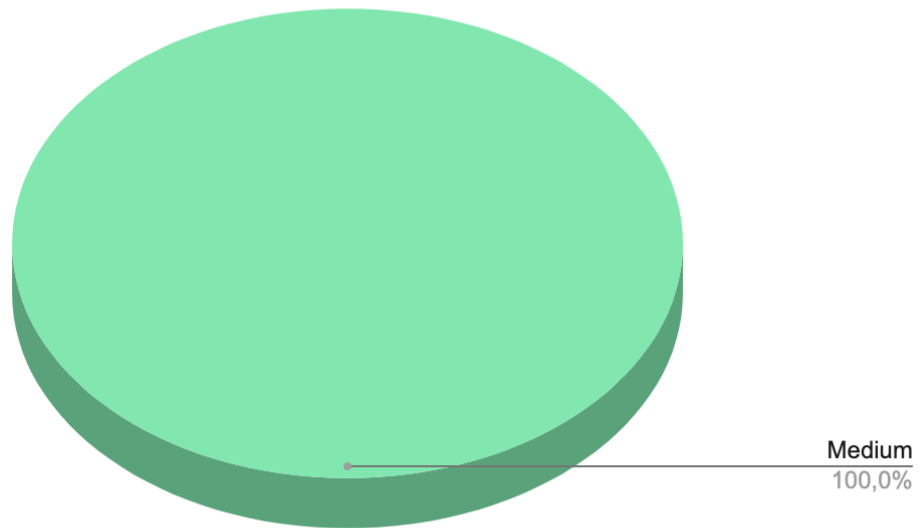


Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found 1 medium and 2 low severity issues.

After the second review, security engineers found 1 medium severity issue.

Severity Definitions

Risk Level	Description
Critical	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
High	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
Medium	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
Low	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution

2. Missing event for changing whiteList, receiveFun, implAddress, _baseHeroURI, operator, configs, marketFeeInBps, summonersArenaHeroes

Contracts: SAHero.sol, SAHeroMarket.sol

Functions: changeWhiteList, setReceiveFunAddress, setImplAddress, setBaseTokenUri, setOperator, pushNewConfig, setMarketFeeInBps, setSummonersEraHeroesAddress

Changing critical values should be followed by the event emitting for better tracking off-chain.

Recommendation: Please emit events on the critical values changing.

Status: fixed



Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found **1** medium and **2** low severity issues.

After the second review, security engineers found **1** medium severity issue.
