This report presents the findings of the security assessment of the Customer's smart contract and its code review conducted between September 6<sup>th</sup>, 2021 - September 8<sup>th</sup>, 2021. The second code review conducted on September 9<sup>th</sup>, 2021.

## Executive Summary

According to the assessment, the Customer's smart contracts are well-secured.



Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found **1** medium and **1** low severity issue.

After the second review security engineers found all issues were addressed.



## Severity Definitions

Risk Level	Description
<b>Critical</b>	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
<b>High</b>	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
<b>Medium</b>	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
<b>Low</b>	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution



## Audit overview

No critical issues were found.

### ■ ■ ■ High

No high issues were found.

### ■ ■ Medium

The owner could withdraw an entire amount of BWP tokens

While auctions are still in progress, the owner could withdraw any amount of the BWP token, which could lead to the impossibility to end the auction, because of not enough BWP tokens to send to the seller.

**Recommendation:** Please make sure there is always enough tokens left to end all auctions.

**Fixed before the second review.**

### ■ Low

Reading array length in the loop

Reading the `auctions.length` in the loop is a bad idea, because of burning gas. It's might be much better to read and store it into the local variable.

**Recommendation:** Please store array length to the local variable.

**Fixed before the second review.**



## Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found **1** medium and **1** low severity issue.

After the second review security engineers found all issues were addressed.
