## Executive Summary

According to the assessment, the Customer's smart contracts are well-secured.



Our team performed an analysis of code functionality, manual audit, and automated checks with Mythril and Slither. All issues found during automated analysis were manually reviewed, and important vulnerabilities are presented in the Audit overview section. All found issues can be found in the Audit overview section.

As a result of the audit, security engineers found 2 low severity issues.

After the second review security engineers found all issues were addressed.

## Severity Definitions

Risk Level	Description
<b>Critical</b>	Critical vulnerabilities are usually straightforward to exploit and can lead to assets loss or data manipulations.
<b>High</b>	High-level vulnerabilities are difficult to exploit; however, they also have a significant impact on smart contract execution, e.g., public access to crucial functions
<b>Medium</b>	Medium-level vulnerabilities are important to fix; however, they can't lead to assets loss or data manipulations.
<b>Low</b>	Low-level vulnerabilities are mostly related to outdated, unused, etc. code snippets that can't have a significant impact on execution

## Audit overview

### ■ ■ ■ ■ Critical

No critical issues were found.

### ■ ■ ■ High

No high severity issues were found.

### ■ ■ Medium

No medium severity issues were found.

### ■ Low

1. Empty constructor.

It's recommended to put constant arguments to super constructors in the `is` section just to not produce an empty constructor for the contract.

**Contract:** XPNet

**Recommendation:** Replace `<XPNet is ERC1155>` with `<XPNet is ERC1155("XPWRP")>` and remove an empty constructor.

**Status:** Fixed.

2. Magic numbers.

There's a magic number "2" through the contract which is a value assigned to the addresses in the "nftWhitelist" mapping.

**Contract:** Minter

**Recommendation:** Store the magic number into some self-descriptive constant.

**Status:** Fixed.



## Conclusion

Smart contracts within the scope were manually reviewed and analyzed with static analysis tools.

The audit report contains all found security vulnerabilities and other issues in the reviewed code.

As a result of the audit, security engineers found **2** low severity issues.

After the second review security engineers found all issues were addressed.
